

**PLAYHOUSE RAFFLE OFFICIAL CONTEST RULES**  
**Important: Please read these rules before entering the Contest.**

**1. Eligibility.** CONTEST OPEN ONLY TO RESIDENTS OF THE U.S. IF YOU ARE NOT A RESIDENT OF THESE AREAS, YOU ARE NOT ELIGIBLE TO WIN A PRIZE, AND HBAF RESERVES THE RIGHT NOT TO AWARD PRIZES TO ENTRANTS WHO RESIDE IN OTHER JURISDICTIONS. **If you are under the legal age of majority in your state or province of residence (a "Minor"), one of your parents or legal guardians must submit a signed, written statement that they have read, understood and agree to these Contest rules with your entry, and that such agreement constitutes acceptance of these Contest rules on behalf of you and themselves.** To be eligible to win a prize, entries must be completed and received by HBAF in the format designated below. Employees of HBAF and immediate families of each are not eligible to win any prizes. All applicable federal, state and local laws and regulations apply. Offer void where prohibited. No mechanically or electronically reproduced entries will be accepted. All raffle tickets must be submitted to the HBAF at the Crown Center by March 30, 2008 at 3:30 pm.

**2. Disclaimer.** HBAF, all participating sponsors and any of their respective parent companies, subsidiaries, affiliates, directors, officers, professional advisors, employees and agencies will not be responsible for: (a) any late, lost, misrouted, garbled or distorted entries; (b) any Contest disruptions, injuries, losses or damages caused by events beyond the control of HBAF; or (c) any printing or typographical errors in any materials associated with the Contest.

**3. Contest Period.** The Contest period is from **January 11, 2008 to March 30, 2008 at 3:30 pm** (the "Deadline"). All entries must be received by the Deadline to be eligible to win a prize.

**4. How to Enter.** Raffle tickets may be purchased from January 11, 2008 through March 30, 2008 at 3:30 pm. Buyers must complete the raffle ticket stub, available from the HBAF office, HBAF volunteers, participating HBAF Member Companies and at the Carolina Home and Garden Show on March 28, 2008 from 12:00 pm to 7:00 pm, March 29, 2008 from 10:00 am to 6:00 pm and March 30, 2008 from 12 pm to 3:30 pm. Raffle ticket requests will be honored on a first come-first served basis. Not responsible for lost, late or misdirected entries or entries not received in time for the drawing. All entries must be received by March 30, 2008 at 3:30 pm to be eligible. Based upon the number of raffle tickets printed, the approximate odds of winning a prize is 3:5000. Actual odds of winning will depend on the number of raffle tickets sold and eligible entries received by the deadline of the drawing. By entering the Contest, you consent to being placed on a mailing list for promotional and other materials.

**5. Prizes. Three (3) Custom Playhouses valued at over four thousand dollars (\$4000) each will be raffled.** Prizes are not transferable. No substitutions or exchanges (including for cash) of any prizes will be permitted, except that HBAF reserves the right to substitute a prize of equal or greater value for any prize. Limit one prize per household or address. All prizes are awarded "AS IS" and WITHOUT WARRANTY OF ANY KIND, express or implied, (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose)

**6. Winners.** There will be three (3) prize winners. The winners will be determined from all eligible raffle tickets purchased in a random drawing to be held at the **Carolina Home & Garden Show at the Crown Coliseum** (1960 Coliseum Drive, Fayetteville, NC 28306) on **March 30, 2008 at 4 pm**. The drawing will be conducted by Executive Officer Natalie Woodbury, President Billy Hylton or by another representative of HBAF, whose decision is final on all matters relating to this raffle. Ticket holders need not be present to win. One (1) prize winner, per person per household. If a prize winner's name or household is drawn more than once, a new raffle ticket will drawn until an eligible name is chosen. Winners who are not present at the time of the drawing will be notified by telephone on March 30, 2008. Winners who are unreachable by telephone as of March 31, 2008 at 12 noon will be disqualified and an alternate winner will be chosen.

**WINNER MUST TAKE POSSESSION OF THE PRIZE ON MARCH 31, 2008. IF WINNER IS UNABLE TO TAKE POSSESSION ON THIS DAY, HBAF RESERVES THE RIGHT TO CHOOSE AN ALTERNATE WINNER. HBAF AGREES TO TRANSPORT THE PRIZE ON MARCH 31, 2008 TO WINNER'S PLACE OF RESIDENCE NOT TO EXCEED 30 MILES FROM THE HBAF OFFICE. PRIZES WILL BE DELIVERED BY FORKLIFT, WINNER AGREES TO PROVIDE A 10 FOOT PATH FOR DELIVERY OF PRIZE. WINNER AGREES TO HOLD HARMLESS HBAF AND ITS AFFILIATES AND SUBSIDIARIES, ALONG WITH EACH OF THEIR OFFICERS, DIRECTORS, EMPLOYEES, AGENTS, SPONSORS AND CONTRACTORS ANY DAMAGE CAUSED BY DELIVERING THE PRIZE.**

**7. Taxes and Rules.** The winner is responsible for any and all federal, state and local income or excise taxes, fees assessments, permits and like charges associated with the prize. **12. Miscellaneous.** The Contest and these Official Rules will be governed, construed and interpreted under the laws of the United States. Entrants agree to be bound by these Official Rules and by the decisions of HBAF, which are final and binding in all respects. HBAF reserves the right to change these Official Rules at any time, in its sole discretion, and to suspend or cancel the Contest or any entrant's participation in the Contest should unauthorized human intervention or other causes beyond HBAF's control affect the administration, security or proper play of the Contest or HBAF otherwise becomes (as determined in its sole discretion) incapable of running the Contest as planned. Entrants who violate these Official Rules, tamper with the operation of the Contest or engage in any conduct that is detrimental or unfair to HBAF, the Contest or any other entrant (in each case as determined in HBAF's sole discretion) are subject to disqualification from entry into the Contest.
